#### **CB8 Staff Present**

Michelle George, District Manager Julia Neale, Community Coordinator The regular meeting of Community Board 8 was called to order at 6:55 pm by Ms. Irsa Weatherspoon, Chairperson. The Chairperson introduced those on the dais, which were First Vice Chair Gail Muhammad, Second Vice Chair, Deborah Young, Third Vice Chair, Nizjoni Granville, District Manager, Michelle George, Community Coordinator, Julia Neale, and Robert Witherwax, who would serve as Secretary during the meeting.

Chairperson Weatherspoon acknowledged, welcomed, and congratulated newly appointed community board members. She asked each of those present to introduce themselves and say a few words about why they joined the Board.

Mr. Peter Anekwe stated that he has lived in the community since 1969, watching the neighborhood change. He stated that he joined the Board because he believed everyone that lives in the district should have a vested interest in what is happening in the community around them.

Mr. Mohammad Hassan stated that he operates a Mosque in Prospect Heights and does a lot of community organizing with mosque members.

Ms. Robin Smith stated that she has been in the Crown Heights community since 1968 and is a Veteran, interested in serving on the Veterans Committee.

Ms. Dana Thomspon stated that she has been in Prospect Heights for 49 years. Believe in investing in the community, part of school district 13.

Mr. William Meehan, lives in Prospect Heights by way of Long Island. Believe in democracy and that the work done in Community Boards is integral to improving quality of life.

Mr. Jamell Henderson, served on Community Board 8 twice before. Lives in Kingsboro Houses and he is a community activist. He is in his final year of doctorate of education program, he will be a 5 time graduate. He wants to protect community and ensure that our voices are heard and listened to.

Ms. Courtney morgan, Prospect Heights, new to Brooklyn, mother, teacher, professor, wife, small business owner. Ready to serve the community.

Tafari john0king: born and raised in crown heights duration of life except for college. Want to focus on youth force and work development programs. Noticed in community needs statement that one of the top three priorities is violence and the need to assist young men and young people to stay on the right path. See in some schools that ther is a lack of support and services, so want to promote opportunities to youth similar to what he had an opportunity to enjoy.

Malik jabati, been in crown heights about 5 years by way of DC. Found out about community boards and figured it would be an opportunity to help make crown heights a safer and better neighborhood for everyone.

Irsa: welcome everyone, we can use each and every one of you. Ready to get to work.

Acceptance of April mins, motion lazur, second staton.

#### HPD:

542 dean: the two sites are right on the edge of AAMUP. Tacking on the two HPD sites for the ULURP process. Will be included in the broader neighborhood plan.

3500sqft of amenity space on the ground floor. Communal dining room, conference room, laundry. 2000sft of community public space, looking for recommendations for that. 6500 sqft of open space.

ICL person: help those with housing insecurity or struggling with behavioral health issues. Serve about 13k a year. Have 140 programs across the boroughs but predominately in Brooklyn.

Deb: asked ICL about 839 st. marks. Yes, in disrepair, still fighting lawsuit that blocked their development plan. Haven't figured out what to do with it yet.

Fior: how can seniors afford these rents when the average monthly fixed income is about 1800. Will cb8 seniors have preference? Also, how many seniors need family sized units when they don't have kids.

Crystal: this is a first step and still has to go through public process. Wanted to clarify that 40% is the maximum that someone can make. If making less than 43k annually, can still be eligible. Her office will be assisting with the application process. Re the preference, there was recently a court ruling that ruled against community preference. Would like to continue seeing community preference, but there was an argument that majority race communities something or other. Mentioned majority white communities that would not allow mixing and bringing in other races.

Hpd lady: the workaround is to have community fairs to ensure that more residents in the district apply which would then increase the community preference.

Kim Watson: how often would seniors have access to services, especially case management? As needed. Like that the giveback is built in with the community public space.

Lazur: nyers all over the city have difficulty accessing HRA. Will they have a physical presence on site? No. will provide funding for services. Project based section 8 is the vision here? Yes. Dependent on the senior remaining in the building. Any senior that moves into the building after a senior vacates, they will still enjoy the 30% rate. When first pitched in 2020, is the rezoning now that it's connected to AAMUP, will it only include these two buildings or the surrounding ones as well?

Jonah: are including just a small number of lots outside of the building footprint boundaries. Becaue the sites are along the middle of the block and abut the park, (38) no idea what he said.

Robin smith: is there any priority or preference for senior vets? No additional set aside for them.

Peter anekwe: in regards for the preferences, when you say 5%, it's about 7 or 8 apartments. Is that a hard number or flexible? Fixed number at this time.

Jamell Henderson: why didn't any of the images include arts or cultural aspects of this community? Also, this is difficult for seniors to understand. Criticized the quality of the presentation. Beginning of a very long process.

Gail: extend invitation to attend seniors committee to get feedback from the seniors on the committee.

516 bergen street: with bridge street. Serving households 1 to 4 persons.

Apex building group (they have that mega development in east new York by gateway): multicultural programs still in development. Seeking feedback. Needed to create 23 parking spaces for the city vehicles that will be displaced. Will be designed to passive house standards.

Most units for families earning up to 60% of the AMI, about 80k.

Staton: asked about UAP and if it will be any taller. Not intending at this time to extend beyond what is presented. Crystal: not set in stone. Details can change, might change.

Pettway: question about working in best interest of all tenants.

Peter: design for the building is supposed to address the needs of the community. One of the things lacking is parking. Crystal: both projects are able to provide deeply affordable housing permanently and one of the requirements is to maximize housing over parking.

Anika roach: does the section 8 apply to this building as well?

Lazur: happy to see inclusion of family sized units at affordable levels. Also, can more u nits be made accessible? All units will be created in such a way that conversion to ADA accessibility can be accomplished within 24 hours.

Crystal: passed a law last year for universal ADA by design.

Courtney morgan: express disappointment that neither presentation talked about engagement with community and how the project site would be integrated into the fabric of the community. Didn't hear anything about fostering and belonging. No one mentioned improvements to the playground or park, planting street trees, etc.

The EST Committee met on Tuesday, April 30, 2024 at Crown Heights Center for Nursing and Rehabilitation located at 810 St. Marks Avenue. The committee discussed the street co-naming application in honor of Mrs. Miriam Carter at the northeast intersection of Kingston Avenue and Pacific Street.

The committee was impressed by the history of the community revived by the co-name request. Details of the co-naming application include the following:

- a. Miriam Carter founded a drum and bugle corps at her home at 1529 Pacific St in 1949.
- b. Until her death in 1963, and for a decade thereafter, the Carter Cadets played a critical role in the lives of many African-American youths in Brooklyn.
- c. The Carter Cadets participated in numerous competitions, and even traveled to Washington DC in 1961 to participate in Bayard Rustin's first "March on Washington"
- d. Numerous alumni of the Carter Cadets found each other through social media, and have applied to Brooklyn CB8 for a co-naming in honor of Miriam Carter and the Carter Cadets.

The committee voted unanimously with 19 in favor to support the street co-naming request and hopes the full Board supports its recommendation.

Don't think there has been a co-name application before the committee that was as exciting and well put together as this one was.

Lazur: do they still exist? Veronica birdsong: Got big and branched out and split up. Some graduates are instructors with other bugle corps.

## **Executive Committee**

The Executive Committee met on Thursday, May 2, 2024 In addition to the Chairperson, Irsa Weatherspoon present were: 1<sup>st</sup> Vice Chair, Gail Muhammad, 2<sup>nd</sup> Vice Chair, Deborah Young, Mark Thurton, Brian Saunders, Secretary, Robert Callahan

The committee discussed several changes to the Board's committee structure. These changes are necessary to ensure that all essential service areas are covered. As per CB8's By Laws, Article 8.1C, the Board has authority to merge or separate committees so long as all of the areas of concern for residents are addressed by at least one committee. The following mergers allow us to be compliant with our By Laws.

- 1. Due to the fact that the Parks Committee and the Youth & Education Committee have been inactive for several months lacking a chairperson for each committee, the Executive Committee voted to merge the two committees into the Parks, Youth, and Education Committee or "PYE." These two committees met on the same day and shared many of the same members, and often discussed similar issues/items. The merger at this time allows CB8 to consider upcoming Parks' initiatives, especially as they relate to youth services and activities.
- 2. Due to the increasing need for the Land Use and Housing Advocacy committees to discuss the same topics thus leading to more joint meetings, the Executive Committee voted to merge the two committees back into one larger group. The two committees had been one in the past and consequently split into two to allow for non-Landmarks and non-zoning change issues a forum for discussion. Dwindling LPC applications, sweeping changes to the NYC Zoning Text Amendment, and a neighborhood wide rezoning proposal (Atlantic Avenue Mixed Use Plan) make it possible now to maximize efficiency by combining the two committees.

The Executive Committee voted unanimously and hopes the full Board supports these two committee mergers.

Lazur: so for attendance requirements for board members, do the merger count as one or two? One.

Meehan: give an example of an item that the two committees discussed together.

Morgan: is there a chair for the committee with the merger? Yes. Kim Watson will chair PYE.

#### **Land Use**

The Land Use Committee met jointly with the Housing Advocacy Committee on Wednesday, May 8, 2024 at Stuy Park Houses located at 77 New York Avenue. The committee discussed the LPC application for a Certificate of Appropriateness for 173 Prospect Place.

The application includes the following details:

- Renovation of townhouse including conversion of 3-family home to one family
- Extending the half-rear two-story extension to full width of building
- The extension will contain steel and glass wall, and the second floor wall openings will also be steel and glass
- Bulkhead on roof inclusive of solar panels, but will not be visible from the street

The applicant's representative stated that few of the rear facades on the block have precious features. In addition, several homes on the block have rear extension and this one will actually reduce bulk despite becoming a full width extension as it is not adding height and will also remain the same depth. Many of the modifications in the plan are designed to work around and with, while minimizing difficulty of undoing some of the damage to the rear façade from previous renovation work.

The current extension is built with multiple materials and the project plan seeks to create a rear façade that is uniform and in line with turn of the 20<sup>th</sup> century elements such as salvaged bricks, steel, and glass mimicking and evoking the conservatory concept of the era. The ultimate goal of the design is to maximize light in the rear of the property as the windows are north facing, meaning that little light is available naturally during the day.

The committee had several comments related to the reduction in building class from a multi-family to a single family. The applicant's response was that it would be several families in a co-living concept sharing a kitchen. Additional comments expressed concerns for neighbors having their own light and air reduced by the extension, to which the applicant responded that going full-width on the extension and the type of materials would have less of an impact on light and air, and should also create a more visually appealing experience for neighbors that face the rear yard due to the creation of style uniformity.

A motion by Gib Veconi to support the application with the condition that the applicant revert the top floor stylings to three punched window openings failed. Mr. Veconi argued that retaining the three punched window openings would require less removal of the rear façade and fewer changes to the property structure. The applicant's architect countered stating that there has already been so much damage from other renovation projects that it would not be cost effective to accommodate the request as they would then have to add back a support beam that would interfere with other components of the home not under consideration in the LPC application.

Robert Callahan made a motion to support the application as presented without any conditions on the window openings type or style, with the requirement that the applicant contact the neighboring properties abutting the rear yard. The motion was seconded by Robert Puca and carried with a final vote of 12 in favor with 9 abstentions. The committee hopes the full Board supports its recommendation.

Mark: applicant present? No.

Hassan: mentioned that rear façade is less of a problem than the rear yard.
