UPDATES FROM NYC PARKS

The NYC Parks Department would like to update the community on the following:

 A large staging area inside Brower Park will be installed along the western Prospect Place entrance, going from the entrance east into the middle of the park. This staging area will be used by the Dept. of Design and Construction (DDC) during reconstruction work of the retaining wall separating the park from the backyard of the Children's Museum. This closure will not stop pedestrians from using this path to enter the park and accessing any areas of the park, the path will just be shrunk so DDC can use it for staging/vehicle access. This work will start the week of April 15th and take approximately two years to complete.

On April 22, 1970, nearly one million New Yorkers paraded, marched and strolled up and down a car-free Fifth Avenue to celebrate the inaugural Earth Day. Now, 54 years later, NYC has expanded its Car Free Earth Day to include all 5 boroughs, and multiple miles of NYC streets.

Along with expanded electric car charging stations, increases in citywide electric vehicles (including the NYC Fleet), increased bike lanes, increased ferry transportation, treatment of NYC waterways, and composting and recycling programs citywide, New Yorkers are working hard to live more sustainably and celebrate more responsibly.

Car-Free Earth Day takes place this year on April 20. Grab your bike, your shades, your family and friends and hit the streets to celebrate living green!

NEIGHBORHOOD SUPPORT TEAMS

In accordance with Local Law 102, the Mayor's Office is calling upon community boards, council members, and business improvement districts to submit information that will inform the process of creating neighborhood support teams. Support teams will work within existing City resources to address quality of life issues in specific geographic areas.

This request for expressions of interest is designed to draw on the insights of community stakeholders to better understand the specific issues affecting New York City's neighborhoods and residents. This includes but is not limited to graffiti issues, road and sidewalk quality, street cleanliness, noise pollution, public space issues, and access to city services or community centers.

The City will analyze the results of these submissions and release a report on the findings, which will inform a formal application process. The application will include a written form and may have other components such as stakeholder interviews, community meetings and/or objective conditions observations. The application will be scored based on objective criteria, to be determined by the results of the request for expressions of interest. Sample criteria may include: the comprehensiveness and complexity of the issue, whether addressing this issue would promote equal access to public resources and services, whether there have been prior attempts to address these concerns, and the level of community buy-in.

Once the neighborhood support teams are selected, they will coordinate across agencies and use the insights and ideas of local communities to creatively address the issues identified over the course of one year. All fields are required, excluding the attachments section.

NEWS AND UPDATES FROM ASSEMBLYMAN ROBERT CARROLL

Assemblyman Robert Carroll is pleased to inform the community that his E-Bike Bill, (A.275), which would require the New York State Energy and Development Authority Research (NYSERDA) to establish a rebate program for ebikes and scooters modeled on New York's Drive Clean program for cars, recently was voted out of the Assembly Committee on Energy, has advanced in the Assembly. The bill calls for a rebate to purchasers of e-bikes and e-scooters of 50% up to a maximum of \$1,100. This legislation would make a sustainable form of transportation affordable to a wide range of New Yorkers and help ensure that e-bikes and scooters purchased for work or leisure meet appropriate safety standards and he will continue to work for its adoption.

CAMPAIGN AGAINST HUNGER GREEN TEAM

Are you between the ages of 14 and 24 and seeking to learn more about innovative farming techniques, mastering composting skills, or becoming a champion for food justice and security in your local community? If so, then you are encouraged to join the Campaign Against Hungers Green Teen Workforce Program (for 18-24 year olds) or the Green Tean Internship Program (14-18 year olds). These two dynamic employment programs will allow you to collaborate with expert farmers and engage in interactive workshops.

The Green Teens Internship Program is 10 weeks in the summer and the Green Teens Workforce Program is for 10 months throughout the changing The Green Teens programs are seasons. compensated farm-based work experiences, where youth apprentices receive intensive handson training in farm and market management. Green Teens assist with day-to-day farm work to help grow over 100 varieties of certified allnatural fruits, vegetables, and flowers. Program participants are also involved with plant and animal care, farmers' markets, produce sales, and site maintenance. Each year, Green Teens help distribute roughly 20,000 pounds of produce in

our community, including many food deserts. Throughout the growing season, there are also opportunities to engage in neighborhood outreach, attend field trips and workshops, lead volunteer groups, and carry out independent projects.

At the end of the summer, Green Teens are required to complete a capstone project to demonstrate key learnings from their internship experience. In the fall, all graduating Green Teens in the Workforce Program will have the opportunity to apply to stay on as hired part-time instructors after the summer season in one of their community or intergenerational learning programs.


