# District Manager's Report

# Bedford Avenue Protected Bike Lane

The New York City Department of Transportation (NYC DOT) will begin the construction on a new protected bicycle lane and other major safety improvements planned for Bedford Avenue from Dean Street to Flushing Avenue. NYC DOT Roadways crews will begin milling the street this week, the first step in a multi-week redesign process. Streets typically remain milled for 2-3 weeks before being paved to allow the utility companies to do work that would otherwise require digging up pavement. We expect the entire redesign process along

Bedford Avenue to be completed by the end of the year.

### **DISCRIMINATION SURVEY**

The NYC Commission on Human Rights is requesting your support in spreading the word about their "Understanding New Yorkers' Experiences with Discrimination" survey! (Click to go to survey)

This comprehensive citywide survey explores New Yorkers' experiences and perceptions of discrimination in their daily lives. The survey covers several key themes around the perceptions of where and why discrimination occurs, contributors discrimination. to willingness to report discrimination and familiarity with the Commission. responses will inform the Commission's impact, outreach efforts, and collaborations with other local government agencies.

Available in over 10 languages, this survey is part of the new <u>TogetherNYC campaign</u>, which encourages all New Yorkers to take actions to reduce and prevent discrimination.

### RESIDENTIAL WASTE CONTAINERIZATION

NYC is set to roll out new requirements for trash set out starting fall 2024. These changes are citywide. Containerization will now be mandatory for residential units just like it is for commercial spaces, but there are certain requirements to be in compliance.

Beginning November 12, 2024, all properties with 1-9 residential units will be required to use bins, 55 gallons or less, with secure lids for trash disposal.

If you already use a bin with a secure lid that is 55 gallons or less for trash disposal, you may continue to use it until June 2026. After that, you will need to switch to the official NYC Bin.

NYC is also advancing a plan to containerize trash in larger residential buildings. Buildings with 10 to 30 units will be able to choose between stationary on-street containers and smaller wheelie bins.

Buildings with 31 or more residential units will be required to use stationary, on-street containers for their trash, serviced by DSNY's new automated side-loading garbage trucks. On-street containers will be assigned to a specific building, solely for residents of that building.

### **BALLOT INITIATIVES**

On the November 5th General Election ballot, in addition to candidates for public office, there are six(6) ballot initiatives that must be voted on including a proposed amendment to the NYS Constitution. Below is a brief summary of each of the six initiatives.

# Amendment to Protect Against Unequal Treatment (Statewide)

This proposal would protect against unequal treatment based on ethnicity, national origin, age, disability, and sex, including sexual orientation, gender identity and pregnancy. It also protects against unequal treatment based on reproductive healthcare and autonomy.

A "YES" vote puts these protections in the New York State Constitution.

A "NO" vote leaves these protections out of the State Constitution.

### **Cleaning Public Property**

This proposal would amend the City Charter to expand and clarify the Department of Sanitation's power to clean streets and other City property and require disposal of waste in containers.

Voting "Yes" will expand and clarify the Department of Sanitation's power to clean streets and other City property and require disposal of waste in containers. Voting "No" leaves laws unchanged.

# Additional Estimates of the Cost of the Proposed Laws and Updates to Budget Deadlines

This proposal would amend the City Charter to require fiscal analysis from the Council before hearings and votes on laws, authorize fiscal analysis from the Mayor, and update budget deadlines.

Voting "Yes" would amend the City Charter to require additional fiscal analysis prior to hearings and votes on local laws, and update budget deadlines. Voting "No" leaves laws unchanged.

# More Notice and Time Before Votes on Public Safety Legislation

This proposal would require additional public notice and time before the City Council votes on laws respecting the public safety operations of the Police, Correction, or Fire Departments.

Voting "Yes" will require additional notice and time before the Council votes on laws respecting public safety operations of the Police, Correction, or Fire Departments. Voting "No" leaves laws unchanged.

### **Capital Planning**

This proposal would amend the City Charter to require more detail in the annual assessment of City facilities, mandate that facility needs inform capital planning, and update capital planning deadlines.

Voting "Yes" would require more detail when assessing maintenance needs of City facilities, mandate that facility needs inform capital planning, and update capital planning deadlines. Voting "No" leaves laws unchanged.

## Minority and Women-Owned Business Enterprise (MWBES), Film Permits, and Archive Review Boards

This proposal would amend the City Charter to establish the Chief Business Diversity Officer (CBDO), authorize the Mayor to designate the office that issues film permits, and combine archive boards.

Voting "Yes" would establish the CBDO to support MWBEs, authorize the Mayor to designate the office that issues film permits, and combine two boards. Voting "No" leaves laws unchanged.

**RE-INSTATING YOUR VOTING RIGHTS**

You are eligible for a Certificate of Relief from Disabilities if you have been convicted of any number of misdemeanors and no more than one felony; two or more felony convictions in the same court on the same day are counted as one felony for determining your eligibility. The term "disability" refers to laws that disqualify people from holding certain jobs or other rights because of their conviction.

A Certificate of Relief may remove any mandatory legal bar or disability imposed as a result of conviction of the crime or crimes specified in the certificate. The Certificate of Relief does not, however, enable you to retain or become eligible for public office.

Removing mandatory legal bars restores the right to apply and be considered for employment or license, but does not guarantee the employment or license will be granted.

A Certificate of Relief issued upon release or once on community supervision is a temporary certificate, which becomes permanent when the parolee is discharged from supervision. While temporary, the Certificate may be revoked by action of DOCCS.

In contrast to the Certificate of Relief, you are eligible for the Certificate of Good Conduct even if you have been convicted of more than one felony. You do not become eligible for a Certificate of Good Conduct until a minimum period of time has elapsed from the date of your unrevoked release from custody by

community supervision or from the date your sentence ended.

You must show that you have completed/achieved a certain period of good conduct in the community. You must wait:

- five years if the most serious felony on your criminal record is an A or B;
- three years if the most serious felony on your criminal record is a C, D or E felony; or
- one year if you only have misdemeanors on your criminal record.

A Certificate of Good Conduct has the same effect as the Certificate of Relief. However, the Certificate of Good Conduct may restore your right to seek public office and remove all legal bars or disabilities, or specific bars or disabilities.

The Certificate of Good Conduct issued to you while under community supervision is a temporary certificate. The Certificate becomes permanent upon discharge from supervision.

SAFE DISPOSAL EVENTS

SAFE Disposal Events give residents an easy way to dispose of potentially harmful household items. DSNY hosts SAFE (Solvents, Automotive, Flammables, and Electronics) Disposal events every year. Events are held in all five boroughs, and NYC residents can drop off chemical products, medical waste, and electronics. You may be asked to provide proof of NYC residency (NYS driver license, utility bill). These events are for NYC residents ONLY, not businesses. Commercial vehicles are NOT allowed.

All events run from 10:00 AM to 4:00 PM – rain or shine.

Queens: Saturday, September 14, 2024 Cunningham Park, Ball Field Parking Lot Cars enter on Francis Lewis Boulevard between Union Turnpike and Grand Central Parkway

Manhattan: Sunday, September 22, 2024
Union Square, North Plaza
South side of 17th Street, between Park
Avenue South and Broadway
Cars approach from Park Avenue South &
20th Street. There is a space for walk-ins.

Brooklyn: Sunday, September 29, 2024 Brooklyn Army Terminal, Pier 4 Parking Lot Cars line up at 63rd Street and 2nd Avenue (follow blue signs to Ferry Parking). There is a space for walk-ins.

Staten Island: Saturday, October 19, 2024 Midland Beach Parking Lot 8 Father Capodanno Boulevard & Hunter Avenue Cars approach from Slater Boulevard. There is a space for walk-ins.

## Bronx: Saturday, October 26, 2024

Orchard Beach Parking Lot Cars follow Park Drive to the end. There is a space for walk-ins.

What can you bring to a SAFE Disposal event?

- Automotive products (antifreeze, car batteries gasoline, motor oil, transmission fluid)
- Electronics (computers and accessories, TVs and video equipment, cell phones, tablets, e-readers, video game consoles)
- Household products including cleaners, pesticides, nail polish, paint, compact fluorescent light bulbs, flammable gas, fire extinguishers, rechargeable batteries, thermostats, ecigarettes, vape pens
- Medical items (medications, syringes, needles, scalpels, lancets)

SAFE events do not accept plug-in appliances (microwaves, vacuum cleaners, box fans) or ones containing CFCs.


